## 2019 Amateur Backyard BBQ Rib Competition!

• Entry Fee: \$50

• Set up is between 7am-8:30am on Saturday, September 7.

No Check-ins allowed after 8:30am.

Each participant must be registered in advance of the event in order to compete.

• Each participant must supply their own grill – electric, gas or charcoal, spices & rubs, sauces, ice chest, and small work table plus their own meat for the competition.

• **Pork ribs are the featured item.** Ribs may be spare ribs, **St. Louis** style cut or baby back ribs. The ribs must include the bone. Country style ribs are prohibited. A minimum of 6 pieces must be turned in to the judges at your turn-in time. Turn-in rules will be handed out when you check-in. Meat must be stored in original packaging at **40 degrees or less** and cannot be pre-cooked or pre-marinated. All meat will be inspected when you check-in to assure temperature and quality control and fairness.

• Turn-In time to the Judges will begin at 1:30pm Saturday, September 7<sup>th</sup>. When you check-in, you will be assigned your time.

• One winner will be crowned the Amateur BBQ Rib King!
